(1) Includes employees who permanently left their individual agency during the 2008-2009 financial year. Excludes temporary assignments to other public sector organisations, unpaid leave, or casual employees who did not work in the last pay period.

(2) Employees that moved internally within the SAPS. This includes employees moving to a different role within the same Agency, or transferring to a different Agency within the SAPS.

(3) Employees that separated from the SAPS. This includes employees resigning to a non-SA Public Sector role, or who left the workforce due to: a Targeted Voluntary Separation Package (TVSP); a WorkCover settlement; death; retirement; ill health; study; or family responsibilities.

(4) Those who ended employment in a role during the 2008-2009 financial year, but whose subsequent employment sector was not specified. Reasons for ending employment in a role include: dismissal, contract expiry or resignation. Agencies did not specify whether these employees subsequently moved to a different role within the SAPS or whether they separated entirely from the SAPS.

(5) Includes Ambulance Service Officers and Fire Fighters.

(6) Includes all executives in the South Australian Public Sector.

(7) Includes PSM Act employees located in other public organisations.
